Sustainable Transportation Options from the Airport to the Venue for MFNM 2025 in Barcelona

Barcelona provides a variety of sustainable transportation

options from the airport to the CCIB International Convention Centre, venue for the MFNM 2025. Here are some eco-friendly ways to travel:

- **Metro:** One of the most convenient and environmentally friendly methods is to take the Metro. The L9 Sud line connects directly from Barcelona-El Prat Airport to the Europa-Fira station, where you can switch to the FGC train that brings you closer to the CCIB. This route is not only efficient but also supports our commitment to sustainability.
- **Public Bus:** Another viable option is the public bus. Routes such as the 46 and the N17 (night bus) run from the airport directly to areas near the CCIB. While the journey might take a bit longer than the Metro, it's a good alternative that aligns with green travel initiatives.
- **Electric Taxis or Car-Sharing Services:** For a more direct route, consider using electric taxis or car-sharing services that feature eco-friendly vehicles. Many services in Barcelona offer hybrid or fully electric cars, reflecting the city's push towards reducing carbon emissions.
